AMENDMENT TO THIRD AMENDED STANDING ORDER

AND NOW, this 12 day of March, 1990, the provisions of Paragraph 17 of the Third Amended Standing Order are amended as follows relative to actions filed in the Court of Common Pleas of Beaver County in 1988 and 1989 only. With respect to all actions filed after December 31, 1989, the deadlines set forth in Paragraph 17 of the Third Amended Standing Order shall still apply. The deadlines set forth below shall not apply to Motions for Summary Judgment based upon any grounds other than lack of product identification.

For all actions commenced on or after January 1, 1988 in which plaintiff's discovery deposition has been taken, as set forth in attachment "A" hereto, all Motions for Summary Judgment based upon lack of product identification shall be filed and served on or before May 1, 1990. A Response by plaintiffs or any other party to such Motion for Summary Judgment shall be filed and served no later than August 15, 1990. Failure of any party to respond to such Motion for Summary Judgment in a timely manner shall be deemed as consent to the entry of summary judgment on such Motion, and judgment will be automatically entered on such Motion in the absence of a timely Response without the need for the filing of a Motion for Entry of Judgment.

For all actions commenced on or after January 1, 1988 in which plaintiff's discovery deposition has been taken, as set forth in attachment "B" hereto, all Motions for Summary Judgment based upon lack of product identification shall be filed and served on or before August 1, 1990. A Response by plaintiffs or any other party to such Motion for Summary Judgment shall be filed and served no later than November 1, 1990. Failure of any party to respond to such Motion for Summary Judgment in a timely manner shall be deemed as consent to the entry of summary judgment on such Motion, and judgment will be automatically entered at the time scheduled for oral argument on such Motion in the absence of a timely Response without the need for the filing of a Motion for Entry of Judgment.

For all actions commenced on or after January 1, 1988 in which plaintiff's discovery deposition has been taken, as set forth in attachment "C" hereto, all Motions for Summary Judgment based upon lack of product identification shall be filed and served on or before October 1, 1990. A Response by plaintiffs or any other party to such Motion for Summary Judgment shall be filed and served no later than January 15, 1991. Failure of any party to respond to such Motion for Summary Judgment in a timely manner shall be deemed as consent to the entry of summary judgment on such Motion, and judgment will be automatically entered at the time scheduled for oral argument on such Motion in the absence of a timely Response without the need for the filing of a Motion for Entry of Judgment.

For all actions commenced on or after January 1, 1988 in which plaintiff's discovery deposition has not been taken, the following schedule will apply:
